**The authorization is subject to the following conditions:-**


01. Before execution of works, a certificate is accorded that the work being taken-up for execution qualify for inclusion under BADP as per the guidelines of the scheme. In particular, Executive agencies shall ensure and record a certificate that none of the work being taken-up for execution lie at the distance more than 10 Kms from IB/LOC
02. The execution/implementation of work/schemes be carried out after observing all the codal formalities and as per the guideline on BADP issued by MHA,GOI and the instruction issued by PD&MD from time to time.
03. The expenditure against the approved works shall be restricted to released amount without increasing the scope of work and any savings shall be reported to this Office and shall not be utilized without the approval of competent authority.
04. No scheme other than approved scheme shall be taken up for execution and no past liability whatsoever shall be cleared against the released amount.
05. While executing schemes/works, Executive Agencies shall ensure that there is no overlapping/duplication of the schemes/works with any other programme and no part as a whole of any work already executed under any of the programme.
06. Executive Agencies shall be responsible for ensuring that all schemes being taken up fall strictly within BADP guidelines. In particular they shall ensure that all schemes within 0-10 Kms distance from LOC/IB.
07. Schemes where subsidy element is involved shall not be taken up as per the instruction of the MHA, GOI Department of Border Management.
08. The funds so released shall not be re-appropriated at any level without prior approval of PD&MD.
09. Photographic evidence indicating the pre-execution and past execution past status shall be kept on record for verification/monitoring purpose.
