Pursuant to Director Tribal Affairs J&K Communication no. referred above, sanction is hereby accorded to the release of funds to the tune of **Rs. 50.00 lacs (Fifty Lacs)** only for the **Cluster Tribal Village "Namely Gursai"** under Centrally Sponsored Special Assistance to Tribal Sub-Scheme (SCA to TSP) during the current financial year 2017-18 and placed at the disposal of **Assistant Commissioner Dev. Poonch** who shall utilized the same after completing all necessary codal formalities.

**The authorization is subject to the following conditions:-**

1. The funds shall be utilized only after submission of Detailed Project Report (DPRS) estimating Rs. 1000.00 lacs and subsequent by the competent Authority.
2. The funds shall be utilized as per funding pattern conveyed vide Administrative Department Letter No. TAD/Plg/103/2017 Dated. 06.09.2017.
3. The funds shall be strictly utilized as per the norms and guidelines of the scheme prescribed by the Government of India and after observing all codal/ procedure formalities.
4. No diversion of funds under any case is allowed without prior approval of competent authority.
5. The funds are utilized for purpose for which these are released for.
6. Physical and financial progress report shall be provided to this Directorate after every month.
7. Expenditure be incurred only after getting the scheme /works technically/vetted/ administratively approved by the competent authority.
8. The utilization certificate for these funds be furnished to the Director Tribal Affairs J&K well before 31.03.2018.
9. The activities approved for development of Cluster Tribal Model Village are Education, Health, Skill Development, Agriculture, Horticulture, Tourism, RDD, PWD,PHE and PDD
